MOTION FOR OFFICIAL RECOGNITION

Petitioner, Robert King High Preservation One, LLC ("Robert King") by and through undersigned counsel and pursuant to Sections 120.57(1)(f), 90.202(6), (7), (10) and 90.203, Florida Statutes, and Rule 28-106.213, Florida Administrative Code, respectfully requests the Informal Hearing Officer to take Official Recognition of certain official actions taken by Miami-Dade County. As good cause for the granting of this motion, Petitioner states,

1. On March 28, 2014, Robert King filed its Formal Written Protest and Petition for Formal Administrative Hearing, challenging Florida Housing's review of its Application submitted in response to Request for Applications 2014-003 Affordable Multifamily Housing Developments with SAIL Funding To Be Used In Conjunction With Tax Exempt Bond Financing and Non-Competitive Housing Credits, issued on September 19, 2013 (the "RFA"). Robert King subsequently moved to amend its Petition. 2. The issue in this proceeding is whether the documents submitted by Robert King establish Site Control as required by the RFA. It is the position of Robert King that Site Control has been achieved.

3. Rule 28-106.213(6), F.A.C., provides that Requests for Official Recognition shall be by motion and shall be considered in accordance with the provisions governing judicial notice in Sections 90.201-203, Florida Statutes.

4. Section 90.203, Florida Statutes, provides that a court shall take Judicial notice of any matter in Section 90.202, Florida Statutes, when a party requests it, provides any adverse party with written notice of the request, and furnishes the court with sufficient information to enable it to take judicial notice of the matter.

5. Pursuant to Section 90.202(6), (7), and (10) Florida Statutes, a Court may take judicial notice of the following matters:

(6) Official actions of the legislative, executive, and judicial departments of the United States and of any state, territory, or jurisdiction of the United States

(7) Duly enacted ordinances and resolutions of municipalities and counties located in Florida, provided such ordinances and resolutions are available in printed copies or as certified copies.

(10) Official seals of government agencies and department of the United States and of any state, territory, or jurisdiction of the United States.

6. Pursuant to these sections Robert King submits a certified copy of Resolution No. R-1020-13, dated December 3, 2013, issued by Miami-Dade

County attached hereto as Exhibit "A" and a certified copy of Resolution No. R-855-13, dated October 22, 2013, issued by Miami-Dade County as Exhibit "B".

7. Robert King maintains that Exhibits A and B furnish the Informal Hearing Officer with sufficient information to take Official Recognition of these two documents. The Resolutions confirm that the Leases at issue in this proceeding were approved by Miami-Dade County.

8. By serving a copy of this Motion on Intervenors and Respondent, Robert King is providing all with written notice of this request.

9. Robert King has contacted all counsel who object to this motion to the extent it attempts to seek admission of documents that were not submitted as of the RFA submission deadline. (See 120.57(3)(f), Florida Statutes)

Wherefore, Petitioner requests the Informal Hearing Officer take Official Recognition of Exhibits A and B attached hereto.
